



Vista - Mail/Delivery Account Agreement

Between the undersigned ("User") and SmallOffices4Rent.com, a California Corporation ("Provider") it is agreed that the following services will be provided to User:

Reception Service - The reception area is staffed during Monday - Friday, 8:30am to 5:00pm, with a break with no service from 12:00 noon until 1:00 pm, excluding holidays. Every effort is made to keep to this schedule. However, due to illness, breaks, interruptions, and other unforeseen issues, from time-to-time, there may not be full coverage.

Mail Service - The shared mailing address is 380 S. Melrose Drive, Suite 300, Vista, CA 92081. User's mail will be placed in a designated file within the locked receptionist office. Mail can be retrieved Monday through Friday during regular business hours.

Delivery Service - Package Notification — Packages/documents can be accepted and signed-for by reception staff. They can also be left for pickup at the reception station. User will be notified when packages are delivered.

Conference Rooms - Conference rooms can be rented at the rate of \$35/hour (smaller room) or \$45/hour (larger room). Bookings are based on availability. • User or Provider can cancel agreement at any time with 30-days notice.
• Only the undersigned is covered under the terms of this agreement, whose entitlements, privileges and use of the address are not transferrable.
